

## Resume Upload Sweepstakes

### OFFICIAL RULES

**NO PAYMENT, ENTRY FEE OR PURCHASE REQUIRED. OPEN ONLY TO LEGAL RESIDENTS OF THE FORTY-EIGHT (48) CONTIGUOUS UNITED STATES AND THE DISTRICT OF COLUMBIA (EXCLUDING ALASKA, HAWAII, PUERTO RICO, GUAM, THE U.S. VIRGIN ISLANDS AND OTHER U.S. TERRITORIES). ENTRANTS MUST BE AT LEAST TWENTY-ONE (21) YEARS OLD AT TIME OF ENTRY. VOID WHERE PROHIBITED**

**HOW TO ENTER.** The Women and Drones Resume Upload Sweepstakes (the “Sweepstakes”) begins at 12:01 AM (CST) on March 14, 2022 and ends at 11:59 PM (CST) on November 4, 2022 (the “Sweepstakes Entry Period”). The promotion is sponsored by Women and Drones LLC (“Sponsor”). The Sponsor’s clock is the official time keeping device of the Sweepstakes.

Method of entry (“Sweepstakes Entry Method”):

- Log into the Women and Drones Career Center at [www.WomenanddronesJobs.com](http://www.WomenanddronesJobs.com) to upload your resume to the Career Center website during the Sweepstakes Entry Period.

Limit one (1) entry per person per Job Seeker account for entries using the Sweepstakes Entry Method. Multiple entries through multiple email accounts or logons will not improve your chances of winning. All entry materials become the property of the Admin Sponsor and will not be acknowledged or returned. Entries will only be accepted during the Sweepstakes Entry Period.

Entries will be declared made by the authorized account holder of the e-mail address submitted at the time of entry. “Authorized account holder” is defined as the natural person assigned an account by the organization responsible for assigning the applicable email account used at the time of entry. The authorized account holder may be required to provide proof of identity. If a dispute cannot be resolved, the entry will be deemed ineligible. Any other attempted form of entry is prohibited; no automatic, programmed, robotic or similar means of entry are permitted.

**ELIGIBILITY.** Sweepstakes open only to legal residents of the forty-eight (48) contiguous United States, who are at least twenty-one (21) years old when they enter the Sweepstakes.
